



## ORDINANCE NO. 2020-01

**WHEREAS**, by Ordinance No. 2004-01 adopted May 3, 2004, the Borough of Greencastle adopted as its Municipal Building Code the Pennsylvania Uniform Construction Code, Act 45 of 1999 (hereinafter the "Act"); and

**WHEREAS**, Section 501(c) of the Act and Section 403.121 of the Regulations promulgated thereunder by the Pennsylvania Department of Labor and Industry set forth provisions and standards for the appointment of a Board of Appeals to hear and rule on appeals, requests for variances, and requests for extensions of time under the Act; and

**WHEREAS**, the Borough of Greencastle, on October 26, 2004 entered into an Intergovernmental Cooperation Agreement (the "Agreement") in order to establish a Joint Municipal Board of Appeals in cooperation with other Municipalities located in Franklin County, Pennsylvania; and

**WHEREAS**, the Agreement authorizes a member municipal entity to formally withdraw from the Agreement by Ordinance, provided the withdrawing municipal entity gives thirty (30) days written notice to all other member municipal entities of its intent to withdraw; and

**WHEREAS**, on or about March 3, 2020, the Borough issued written notices to all municipal entities that are party to the Agreement of its intent to withdraw from the Franklin County Joint Municipal Board of Appeals.

**NOW, THEREFORE**, it is hereby enacted and ordained by the Borough Council of the Borough of Greencastle as follows:

1. The Borough of Greencastle hereby withdraws from the Intergovernmental Cooperation Agreement of October 26, 2004 by which the Franklin County Joint Municipal Board of Appeals was established.
2. If any word, phrase, sentence, part, section, subsection, or other portion of this Ordinance or any application thereof to any person or circumstance is declared void, unconstitutional, or invalid for any reason, then such word, phrase, sentence, part, section, subsection, or other portion or the proscribed application thereof, not having been declared void, unconstitutional, or invalid, shall remain in full force and effect.
3. All other Borough of Greencastle ordinances, or parts of ordinances, in conflict herewith, are hereby repealed.
4. Effective date. This Ordinance shall become effective in accordance with the law.




