ORDINANCE NO. 2012 -13

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF GREENCASTLE, FRANKLIN COUNTY, PENNSYLVANIA, AMENDING CHAPTER 185 OF THE CODE OF THE BOROUGH OF GREENCASTLE BY REPEALING ARTICLE I ENTITLED "PER CAPITA TAX".

WHEREAS, pursuant to its powers under the authority of the Local Tax Enabling Act, 53 P.S. §6924.101, et.seq., the Borough enacted Ordinance 2012-11, which established a Local Service Tax to be effective January 1, 2013; and

WHEREAS, the Borough desires to repeal the Per Capita Tax effective January 1, 2013; and

WHEREAS, the Borough Council of the Borough of Greencastle deems it to be in the best interest and for the general welfare of the citizens and residents of the Borough to repeal Article I entitled "Per Capita Tax" of Chapter 185 of the Code of the Borough of Greencastle.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Mayor and Borough Council of the Borough of Greencastle, Franklin County, Pennsylvania, and it is enacted and ordained as follows:

SECTION I: CHAPTER 185 of the Code of the Borough of Greencastle, entitled "Taxation", Article I entitled "Per Capita Tax" consisting of §185-1 through §185-10 is hereby repealed in its entirety and Article I shall be entitled "Reserved" and §185-1 through §185-10 shall be entitled "reserved".

SECTION II: SAVINGS CLAUSE. In all other respects, Chapter 185 of the Code of the Borough of Greencastle shall remain as heretofore enacted, ordained and amended, which said Chapter, as amended, is hereby re-enacted in its entirety herein.

SECTION III: SEVERABILITY. The provisions of this ordinance are declared to be severable, and if any section, subsection, sentence, clause or part thereof is, for any reason, held to be invalid to unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of any remaining sections, subsections, sentences, clauses or part of this ordinance

SECTION IV: REPEALER. All provisions of previous Ordinances of the Borough of Greencastle which are contrary to this Ordinance are expressly repealed.

SECTION V: EFFECTIVE DATE. This Ordinance shall be effective on January 1, 2013.
