The regular March meeting of Council was held on the above date with the following present:-

Burgess D. W. Shinham, and councilmen Walck, Seibert, Gilland, Davison and Stover.

In the absence of President Gardner, Mr. L. R. Walck was nominated and elected President Pro-tem.

In accordances with a resolution passed at the Feb. 5th. meeting, an open session was first held to hear any complaints or petitions. Mr. Chas. Crider appeared before council and asked if any action had been taken toward permitting a curb gasoline pump in front of his premises. Mr. Crider further stated that a pump in front of the Henry Garage on N. Carlisle street had been out of service for more than 15 days, and by terms of the ordinance governing such matters could not now be used. Police Chief Ambrose stated that he had investigated this matter but could not secure conclusive proof that the pump had not been used during the period. Council promised further consideration of the matter. Mrs. Harry Miller requested permission to install a water meter. This matter was referred to the Water Manager.

Mr. Potter, representing Wm. Hammaker, distributor for Ugite asked that Council give consideration to the use of this product when ready to oil the newly made streets. The price quoted was 13 1/2 cents per gallon, applied to streets.

At this point visitors were dismissed and the secretary asked to read the minutes of the preceding meetings. Minutes of the last regular and one special meeting were read, and on motion approved without correction.

Police Chief Ambrose reported 8 arrests for the month.

On motion all of the above reports were approved and accepted.

The secretary read a letter from Sheriff L. R. Huber, quoting a section of the law under which Boroughs are declared responsible for board and lodging of prisoners at the County jail committed for violations of Borough ordinances. This letter was with reference to a bill sent the borough several months ago. Burges Shinham stated that he had talked with County Commissioners and with authorities of other boroughs and found that similar amounts had not been collected from them. The bill was ordered not paid until further investigation could be made.

The matter of fixing the Auditor's fee for the audit of borough accounts was next discussed. It was pointed out that the Borough code prescribed a fee of not less than \$2.00 nor more than \$5.00 for each 8 hours consumed in making the audit. On motion, the fee of \$15.00 each was fixed as a proper fee, and drafts ordered issued for this amount.

Dr. Gilland reported that a request had been made that a street light be installed at the cross-alleys near the Baumgardner Milk Plant. The matter was discussed but no action taken.

A request from the Misses Strite that a retaining wall be placed in front of their East. Baltimore Street property was made, but no action taken.

On motion of Dr. Seibert, seconded by Mr. Stover, the Street committee was authorized to do all necessary grading to secure better drainage on E. Madison Street in the vicinity of the Sam'l. Hicks property, and also to make proper arrangements for the grading of an alley at this point, if necessary.
