The Regular April meeting of Council was held on the above date with the following present:-

President W. Earl Gardner and councilmen Walck, Davison, Gilland, Seibert, Hoachlander and Stover.

Minutes of the last regular meeting were read and approved without correction.

Messers Copenhaver and Mowen of the Rescue Hose Company appeared before Council and exhibited a section of damaged fire hose. Deterioration was said to be due to improper facilities for drying hose and it was suggested that some means be provided. No action was taken, but members of council decided to investigate.

Treasurer Chas. W. Bert, Jr. reported as follows:-

The secretary reported receipts as follows: -

From C. W. Bert, Jr. Water collections, \$ 264.05

Police Chief Ambrose reported eight arrests for the month.

On motion the above three reports were approved and accepted.

The secretary read a letter from attorney Hoke giving information concerning the law governing the entering of leins against unpaid taxes, and the filing of taxes with the County Commissioners. On motion, the secretary was instructed to notify the tax-collector in writing not to turn over uncollected 1933 taxes to the County Commissioners, but to proceed with their collection as in the past, and to enter same with the Prothonotary at the propertime unless otherwise instructed by Council.

In the matter of a refund or abatement in the case of the Hilary Gossard Heirs, in which case a leak on the premises caused an unusual consumption of water, some discussion followed. On motion, it was decided that no refunds could be permitted in such cases. Water Manager Bert was authorized to make a refund of \$ 6.50 to David Mickey, service having been discontinued in this case.

Complaint was made that water from the washing of cars at the Mobilgas filling station on W. Baltimore Street was collecting in the alleys and creating a nuisance. The secretary was instructed to have police notify owner that this practice must be discontinued.

The street committee reported that application for grades and curb lines had been made for the White property on S. Washington Street and the Strite property on East Baltimore Street, The committee was authorized to have County Surveyor Atherton furnish necessary data.

The Street Committee was also authorized to proceed with all necessary patching and repairs to streets and alleys occasioned by the winter weather.

Mr. Roy Stover explained in detail the situation in regard to water supply to his house. The water main supplying his home continues thru his lot to the alley and then branches to supply two houses on S. Carlisle Street. On account of complaint Mr. Stover asked that this condition be changed. On motion Hoachlander, seconded by Walck the water committee was authorised to investigate the situation and provide other service connections for the Carlisle Street houses.

Complaint was made that cars were violating the "Stop" sign at Baltimore and Washington Street, that the same was not properly placed and the intersection not conspicuously marked; also that speeding was becoming a practice. A committee comprising Dr. Gilland as chairman and Messers Walck, Hoachlander and Dr. Seibert was appointed to investigate the above traffic conditions and to put in effect proper remedies.
