Regular Meeting, Council Hall, May 8, 1934. 7:30 P. M.

The regular May meeting of Council was held on the above date with the following present:-

Pres. W. Earl Gardner, Burgess, D. W. Shinham, and Councilmen Walck, Gilland, Seibert, Davison, Hoachlander, and Stover.

Minutes of the last regular meeting were read and approved without correction.

Treasurer, Chas W. Bert, Jr. reported as follows: -

Balance in Borough account, --- \$ 286.90

Balance in Bond account, --- \$ 2107.40

The secretary reported the following receipts:-

From Green. L. H. F. & P. Co. Pole tax, \$ 75.60 From Chas. W. Bert, Jr. water rents, \$ 3883.54

Police Chief Ambrose reported five arrests for the previous month.

A draft to the amount of \$ 12.00 was ordered issued in favor of John B. Diehl this amount being a refund to correct error in billing of trolley rails.

Much discussion followed concerning ways and means to better control traffic at Baltimore and Washington Sts, and as to enforcement of law with regard to "stop" sign at that point. On motion of Mr. Walck, amended by Mr. Gardner, the Burgess was requested to have the police officer stand in the center of the intersection to direct traffic during the time when school-children are on their way to and from school; also to strictly enforce obediance to the "Stop" sign, and make arrests for violation.

The Burgess and others stated that many complaints had been made concerning conditions in the alley near the Baumgardner milk plant. Parking of cars in the alley interefered with the removal of cars from private garages; and conduct of some of the patrons was such as to be a nuisance to neighbors. The police was instructed to enforce ordinace relative to parking, and to inform Mr. Baumgardner that unless conduct on and near the premises was improved, steps would be taken toward the revocation of his license.

Mr. Walk of the Street Committee stated that he had been informed by State Highway employees that grades and curb lines had been established by the highway dep't for all streets on which there are state highways. On motion the secretary was instructed to communicate with the Highway dep't. and if possible have them furnish profiles and establish datum marks at different points so that grades could be more easily and quickly given.
