The secretary reported that the compensation insurance on the fire company and borough employees would expire on Sep't. 19th next; also that the standard insurance companies would no longer write this type of insurance. This would make it necessary to take out the insurance with the State Compensation Insurance fund. Secretary was instructed to make application at once for this insurance. It was the sense of Council that the Antrim Supervisors should pay at least half of the insurance on the firemen inasmuch as fire apparatus is used in township fires more frequently than in the borough. The secretary was instrucated to have Attorney Hoke communicate with the supervisors, and point out to them that the law requires them to have firemen insured while in ther territory, and to make arrangements to collect a part of the amount paid out in insurance from them.

Secretary was instructed to write the Rescue Hose company expressing pleasure at their co-operation in omiting the Wednesday test of the fire siren, and requesting that in the future that tests be made on on Saturdays.

Water Manager, Bert, read a letter from the Pitometer Company in which they agreed to make a survey to determine water leaks in our system. The cost was quoted at \$ 600.00 No action was taken.

Water Committee was instructed to make necessary repairs to motor of Moss Spring pump.
