Robert Wertime, 207 Leitersburg Street, asked Council about the proposed use of the vacant property located in the Franklin Street area and voiced concern that by changing the zoning to Community Commercial the Borough would be required to accept whatever proposed construction met the zoning restrictions.

On a Foley/Webster motion, Council voted unanimously to approve the January 31, 2012 Monthly Disbursement Report.

Mayor's Report

Police Chief Phillippy introduced Officer Anderson and Police Secretary Nicole Bowser who presented Mayor Eberly with an award from National Night Out in recognition of outstanding participation for the second year in a row.

Reports from Committees

A. Administration & Finance

- 1. On a Webster/Smith motion, Council voted unanimously to adopt an ordinance amending Chapter 155, entitled Sewers, Section 155-9 of the Code of the Borough of Greencastle, to provide for an increase in quarterly rates from \$5.00 per thousand gallons to \$6.00 per thousand gallons and an increase in minimum quarterly charges from \$45.00 per quarter to \$54.00 per quarter.
- 2. On a Smith/Burkholder motion, Council voted unanimously to adopt a resolution certifying the need for a rate increase from \$4.22/1,000 gallons to 5.06/1,000 gallons to Antrim Township for waste water services provided consistent with the March 24, 1990 agreement between the Borough of Greencastle, the Greencastle, Franklin County, Authority, and Antrim Township.

B. Community Development

- 1. On a Myers/Smith motion, Council voted unanimously to adopt an ordinance to rezone portions of W. Baltimore Street (S.R. 16) from General Residential (R-2) to Highway Commercial (HC) and portions of W. Franklin Street from General Residential (R-2) to Community Commercial (CC).
- 2. On a Webster/Burkholder motion, Council voted unanimously to approve a Cable Franchise Agreement between the Borough of Greencastle and Comcast of Pennsylvania/Maryland, LLC.

C. Personnel

On a Webster/Foley motion, Council voted unanimously to adopt a resolution to eliminate employee contributions to the Police Pension Plan for 2011 and 2012.

D. Public Facilities

1. On a Foley/Smith motion, Council voted unanimously to designate Friday, May 4^{th} from 8:00 a.m. to 2:00 p.m. and Saturday, May 5^{th} from 7:00 a.m. to 10:30 a.m. as bulky item collection days and times.

2. On a Webster/Burkholder motion, Council voted unanimously to approve an Intent to Award to the apparent low bidder, at the prices indicated, for each of the following four contracts for improvements to the Waste Water Treatment Plant (WWTP) and authorize the Council President to execute the necessary documents to award the contracts when the bonds and insurances have been received and approved by the Borough Solicitor:
