

ORDINANCE NO. 2022-01

AN ORDINANCE OF THE BOROUGH OF GREENCASTLE, FRANKLIN COUNTY, PENNSYLVANIA AMENDING CHAPTER 190 OF THE CODE OF THE BOROUGH OF GREENCASTLE, ENTITLED "VEHICLES AND TRAFFIC", TO PROHIBIT PARKING ALONG PORTIONS OF EAST MADISON STREET AND SOUTH JEFFERSON STREET

WHEREAS, the Pennsylvania Borough Code, 8 Pa. C.S. §§ 101-3501, at Section 1202(31)(iii) authorizes the Greencastle Borough Council (the "Borough Council") to regulate parking and provide parking accommodations to promote the convenience and protection of the public; and

WHEREAS, the Borough's authority to regulate parking is codified at Chapter 190, Article III of the Code of the Borough of Greencastle (the "Code");

WHEREAS, Section 190-27(A) of the Code prohibits parking in certain locations at all times;

WHEREAS, the Borough desires to prohibit parking along a portion of East Madison Street; and

WHEREAS, the Borough desires to prohibit parking along a portion of South Jefferson Street; and

WHEREAS, the Borough Council has determined that it is in the best interest and for the general welfare of the citizens and residents of the Borough to amend certain provisions of Chapter 190 of the Code of the Borough of Greencastle.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Mayor and Borough Council of the Borough of Greencastle, Franklin County, Commonwealth of Pennsylvania, as follows:

<u>SECTION 1</u>. Chapter 190 of the Borough Code, entitled "Vehicles and Traffic", Article III, entitled "General Parking Regulations", Section 190-27, entitled "Parking prohibited at all times in certain locations.", subsection A thereof, is hereby amended to add the following:

Street	Side	Location
E. Madison Street	South	Between North Allison Street and Spring Grove Avenue
S. Jefferson Street feet	West	From Dahlgren Street extending north a distance of 55

<u>SECTION 2</u>. Repealer. All provisions of previous Ordinances of the Borough of Greencastle, or parts thereof, which are contrary or inconsistent with this Ordinance, are expressly repealed.

<u>SECTION 3</u>. Savings Clause. In all other respects, the Code of the Borough of Greencastle shall remain as previously enacted and ordained.

SECTION 4. Severability. The provisions of this Ordinance are severable and if any of its sections, clauses, or sentences shall be held illegal, invalid, or unconstitutional, such provisions shall not affect or impair any of the remaining sections, clauses or sentences.

SECTION 5. Effective Date. This Ordinance shall take effect immediately.
