## Terms and Conditions

1. The Greencastle Area, Franklin County, Water Authority (G AFCWA) will use all reasonable endeavors to supply the quantity of water required by the Applicant by making it available for collection at the G AFCWA fill station.
2. G AFCWA does not warrant or represent that it will guarantee a continuous supply of water in the quantity required by the Applicant. G AFCWA may, at its discretion reduce, interrupt or discontinue the supply of water to the Applicant at any time.
3. Applicant's account must be in good standing to have access to water services.
4. G AFCWA accepts no responsibility for any of the water that the Applicant may take beyond the fill station.
5. The Applicant shall comply with state, federal and local government regulations. (See *Terms of Service*, page one).
6. Smoking is prohibited on G AFCWA property and the applicant shall use on-site trash receptacles for any waste.
7. The Applicant shall avoid spillage, leakage, run-off or ponding from the tanker or the use site.
8. The Applicant must ensure that water drawn from the fill station is filled directly into a tanker approved by the G AFCWA.
9. An approved tanker shall be configured to prevent spillage or leakage while stationary or in transit and be maintained in good order and shall have proper backflow prevention.
10. G AFCWA will send invoices on a monthly basis.
11. Invoice will contain fees and charges applicable to the gallons of water supplied to the Applicant as measured by G AFCWA. Water gallonages will be based on transactions recorded at the tanker filling station provided by the Chief Water Operator.
12. Invoices must be paid by the due date determined on the invoice. G AFCWA reserves the right to terminate water availability if there is an outstanding balance.
13. The Applicant shall obtain and maintain public liability insurance with a reputable insurance company in an amount of not less than state, federal and local government regulation and produce appropriate evidence of insurance if requested by the G AFCWA.
