We are moving forward with the installation of the replacement license plate reader system. The installer has been backlogged with parts and manpower to complete another job but, has promised me that installation will be complete by the 3rd week of March.

We have been able to provide 24/7 coverage throughout the month of February despite having one full-time officer out on sick leave and the other staff shortages. I am looking forward to releasing the pending Civil Service testing date and receiving qualified applicants.



It was collectively decided through discussions with the Mayor that the cost of "Crimewatch" exceeded the benefit to the borough and we can accomplish the same end results utilizing other social media outlets as well as the Borough website.





There is a grant that we are participating in, along with Washington Township Police and Waynesboro Police that fully reimburses the department for the officer's wages performing a roving DUI Patrol.

This grant runs through St. Patrick's Day.



I am pleased to report that the Norfolk Southern grant of \$5000.00 has paid for a second speed limit radar sign. It should be here in a couple weeks and deployed. *The total cost of the sign is \$5001.48*

The current sign has been deployed to E Baltimore St., facing Westbound at Ridge Ave. This will serve as a traffic study to support a letter that the borough is going to send for improvements at that intersection for pedestrians.

Officers have been directed to initiate a traffic enforcement complaint number when they conduct enforcement in these areas to keep track of the number of tickets and warnings issued.



We investigated the thefts of packages from January and solved the case. The juveniles that committed the crime have been identified and the case is closed.
